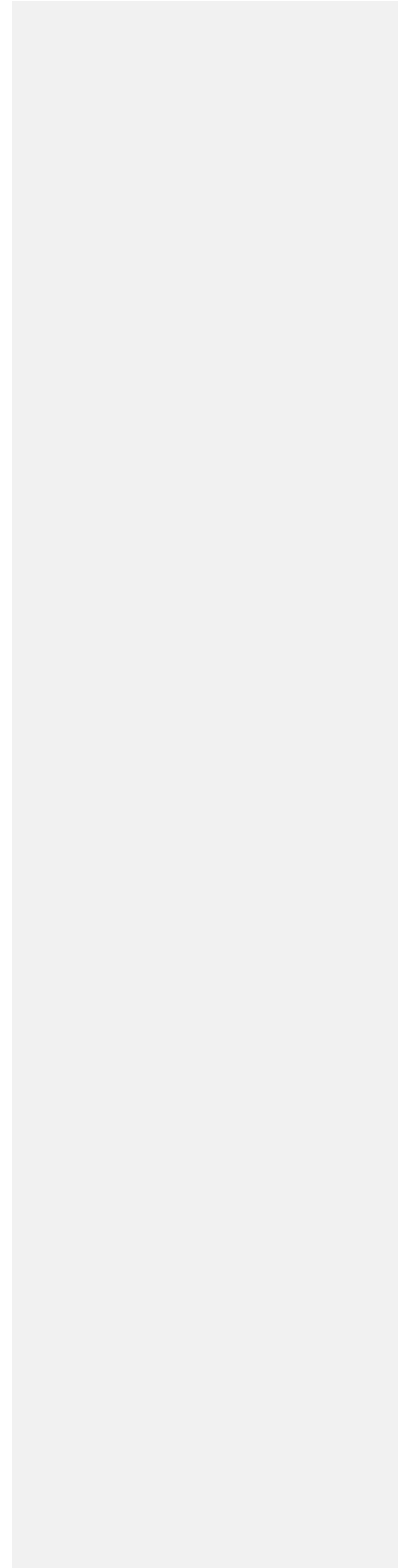

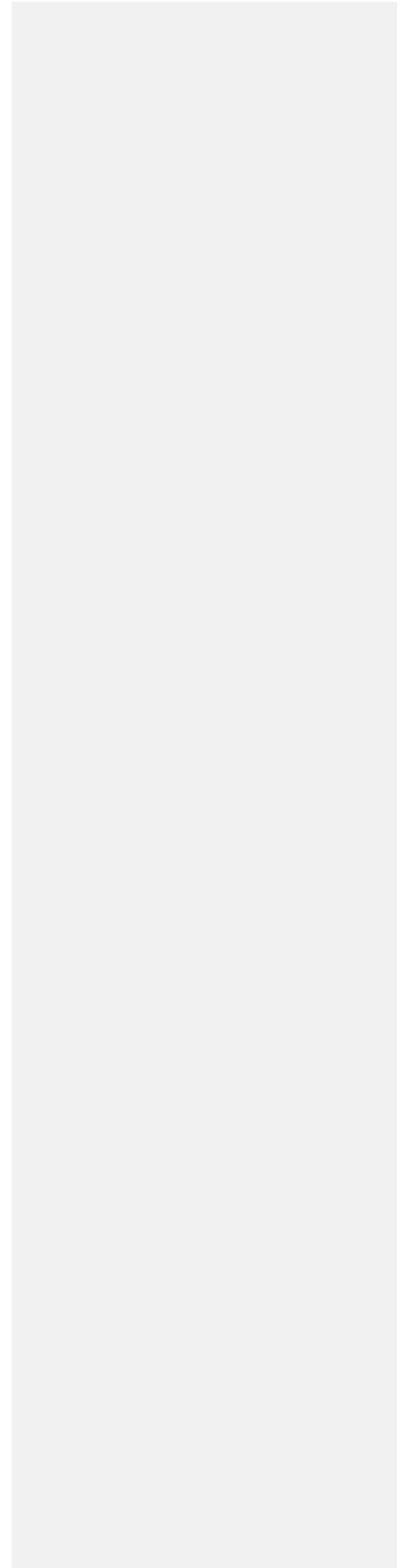

**15. GENERAL COMPLIANCE WITH RESPECT TO THE APARTMENT:**

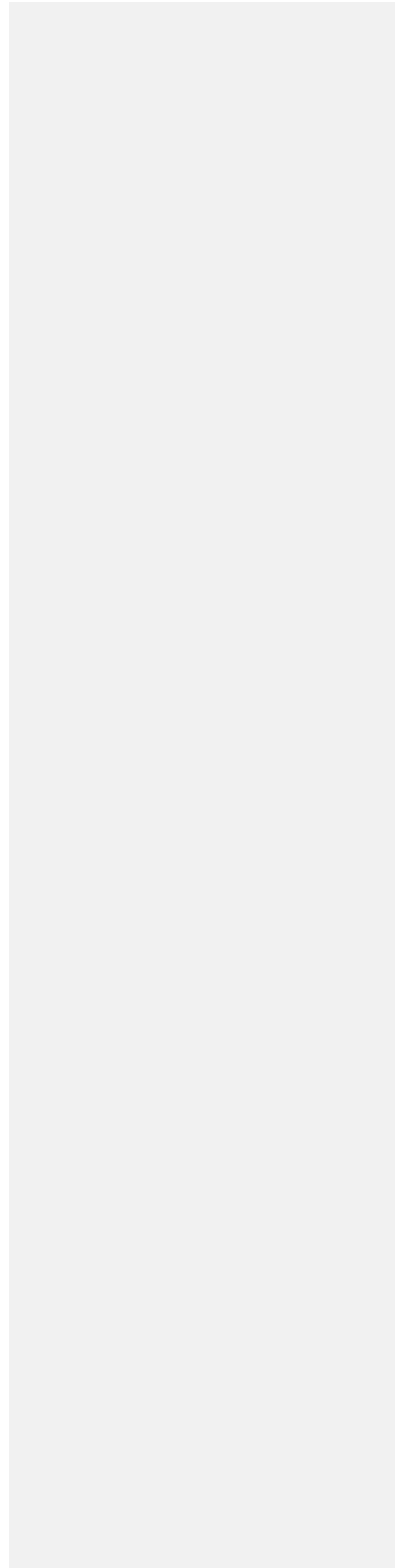
